The curriculum mainly consists of compulsory courses in the $1^{st}/2^{nd}$ semester and elective modules in the 3^{rd} semester. 1 SWS = 45 minutes; most lectures and tutorials comprise 2 SWS = 90 minutes in compound.

Important Rule:

Any compulsory exam, which cannot be completed successfully, is failed.

<u>One retake</u> will be admissible. A second retake shall be allowed only for a maximum of one compulsory exam!





Elective modules/ seminars during the master's study program:

- Only officially recognized modules/ seminars according to the examination and study regulation of the respective master's program can be chosen!
- Successfully completed elective modules/ seminars will be graded once!
- Whether a module/ seminar of another faculty can be credited must be clarified/ applied for recognition with/at the FWW Examination Office beforehand!

Some modules and all seminars require personal registration in advance. Check LSF for module offers and the chair homepages of the respective professor for information about registration deadlines. Seminar places are limited (max. 20) and registration ends for some seminars in June/January for the upcoming semester.

Discrepancies between the information system of the university (LSF/ E-Learning) and the handbook may occur due to fluctuations in professors over the years. All elective modules will be listed in LSF (starting from January/June).

Information (e.g. qualification targets, contents, transcripts, etc.) about modules of other faculties are available in the program handbooks of the respective faculty. Please contact the Examination Office for application details.
